- In the ongoing pursuit of our mission, the Global Privacy Assembly (GPA) advocates for the
 dissemination of our accomplished endeavors, aiming to establish overarching principles that
 allow an elevated and uniform standard of personal data protection on a global scale. We are
 commitment to showcase the collective efforts in promoting cross border transfer mechanisms,
 ensuring the seamless transfer of information while upholding the utmost standards of privacy.
- There have been ongoing efforts related to the Data Scraping Joint Statement. The GPA Working Groups have been actively involved in advancing this initiative, pushing forward with the collaborative work aimed at addressing and refining our approach to data scraping. Moreover, we're looking to the possibility to enhance communication within our International Enforcement Cooperation Working Group, through the idea of establishing an X or LinkedIn account dedicated to the WG. This platform will serve as a hub for sharing valuable content and keeping everyone in the loop with the latest updates. Strengthening our connections and ensuring communication is key to the success of our collective efforts.
- It is anticipated that in the near future, the Data Sharing Working Group will dispatch a finalized document titled in relation to guiding principles on Data Sharing for the Public Good. Moreover, we would like to highlight the importance of International Transfers of Health Data for Research Purposes.
- The upcoming third edition of the handbook on data protection and humanitarian action marks a significant milestone. This development underscores our commitment to advancing best practices in data protection within the realm of humanitarian efforts.
- Furthermore, in adherence to the established timelines, the GPA diligently undertakes the
 responsibility of submitting comprehensive reports. These reports, meticulously prepared and
 aligned with GPA deadlines, are forwarded to both the GPA Secretariat and the Strategic Direction
