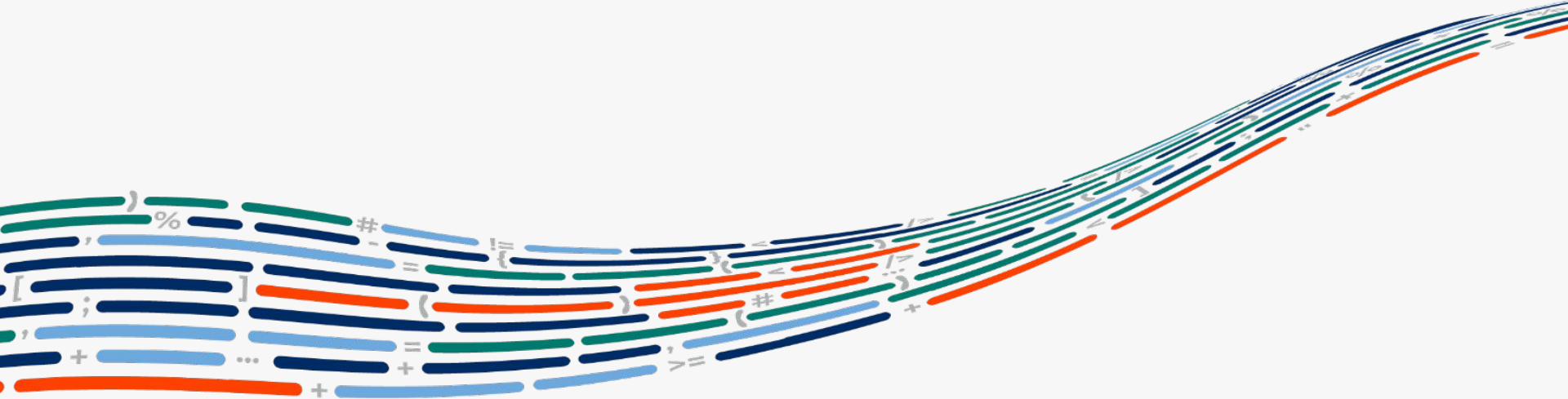

Why a Community of Practice (CoP)?

Problem Space:

There need for a dedicated Community of Practice (CoP) focused on digital identity due to:

- Increased digital identity implementation in public benefits
- A growing set of local and state governments seeking support with digital identity implementation
- Potential digital barriers for applicants
- Privacy, equity, and bias risks associated with existing technologies

Purpose of the Community of Practice

Mission:

To promote the delivery of public benefits to all eligible individuals, including vulnerable populations, by informing how digital identity approaches should be used (*appropriately, responsibly, equitably, and effectively*) in public benefits delivery.

Goals

- Facilitate and Mature a Strong Community
- Amplify Needs and Expertise of People with Lived Experience
- Foster Shared Subject Matter Understanding
- Guide Effective Implementation

Stakeholder Informed CoP Structure

Shared Values

- To ensure access to public benefits.
- To achieve administrative efficiency
- To collaborate for implementation + best practices

Preferred Activity Types

- Learning and information sharing about digital identity topics
 - Examples of government implementation
- To workshop best practices
 - Sector-specific breakouts or roundtables to discuss shared priorities and challenges
 - Cross-sector problem-solving conversations

Stakeholder Informed CoP Structure

Urgent Challenges Related to DI in PB

1. Centering beneficiary experience
2. Digital identity risks
3. Limited opportunities for equitable and accessible verification

Priority Learning Topics

1. Beneficiary experience
2. Data sharing to streamline identity verification, when relevant
3. Requirements related to digital identity in public benefits delivery
4. Interoperability of identity systems
5. Digital Identity Standards
